



# ARP ESSER Health and Safety Plan

---

Section 2001(i)(1) of the American Rescue Plan (ARP) Act requires each local education agency (LEA) that receives funding under the ARP Elementary and Secondary School Emergency Relief (ESSER) Fund to develop and make publicly available on the LEA's website a *Safe Return to In-Person Instruction and Continuity of Services Plan*, hereinafter referred to as a *Health and Safety Plan*.

Based on ARP requirements, 90 percent of ARP ESSER funds will be distributed to school districts and charter schools based on their relative share of Title I-A funding in FY 2020-2021. **Given Federally required timelines, LEAs eligible to apply for and receive this portion of the ARP ESSER funding must submit a Health and Safety Plan that meets ARP Act requirements to the Pennsylvania Department of Education (PDE) by Friday, July 30, 2022, regardless of when the LEA submits its ARP ESSER application.**

Each LEA must create a Health and Safety Plan that addresses how it will maintain the health and safety of students, educators, and other staff, and which will serve as local guidelines for all instructional and non-instructional school activities during the period of the LEA's ARP ESSER grant. The Health and Safety Plan should be tailored to the unique needs of each LEA and its schools and must take into account public comment related to the development of, and subsequent revisions to, the Health and Safety Plan.

The ARP Act and U.S. Department of Education rules require Health and Safety plans include the following components:

1. How the LEA will, to the greatest extent practicable, implement prevention and mitigation policies in line with the most up-to-date guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning;

2. How the LEA will ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services;
3. How the LEA will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policy on each of the following safety recommendations established by the CDC:
  - a. Universal and correct wearing of [masks](#);
  - b. Modifying facilities to allow for [physical distancing](#) (e.g., use of cohorts/podding);
  - c. [Handwashing and respiratory etiquette](#);
  - d. [Cleaning](#) and maintaining healthy facilities, including improving [ventilation](#);
  - e. [Contact tracing](#) in combination with [isolation](#) and [quarantine](#), in collaboration with State and local health departments;
  - f. [Diagnostic](#) and screening testing;
  - g. Efforts to provide COVID-19 [vaccinations to school communities](#);
  - h. Appropriate accommodations for children with disabilities with respect to health and safety policies; and
  - i. Coordination with state and local health officials.

The LEA's Health and Safety Plan must be approved by its governing body and posted on the LEA's publicly available website by July 30, 2022.\* The ARP Act requires LEAs to post their Health and Safety Plans online in a language that parents/caregivers can understand, or, if it is not practicable to provide written translations to an individual with limited English proficiency, be orally translated. The plan also must be provided in an alternative format accessible, upon request, by a parent who is an individual with a disability as defined by the Americans with Disabilities Act.

Each LEA will upload in the eGrants system its updated Health and Safety Plan and webpage URL where the plan is located on the LEA's publicly available website.

The ARP Act requires LEAs to review their Health and Safety Plans at least every six months during the period of the LEA's ARP ESSER grant. LEAs also must review and update their plans

whenever there are significant changes to the CDC recommendations for K-12 schools. Like the development of the plan, all revisions must be informed by community input and reviewed and approved by the governing body prior to posting on the LEA's publicly available website.

LEAs may use the template to revise their current Health and Safety Plans to meet ARP requirements and ensure all stakeholders are fully informed of the LEA's plan to safely resume instructional and non-instructional school activities, including in-person learning, for the current school year. An LEA may use a different plan template or format provided it includes all the elements required by the ARP Act, as listed above.

\* The July 30 deadline applies only to school districts and charter schools that received federal Title I-A funds in FY 2020-2021 and intend to apply for and receive ARP ESSER funding.

# Health and Safety Plan Summary: Freire Charter School

1. How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?

Throughout the execution of our in-person learning program for the 2022-23 school year, TECH Freire will ensure our prevention and mitigation policies are aligned with current guidance from the CDC as well as state and local authorities. To achieve this, the operations team at the Freire Schools Collaborative Network Office will review and analyze any new health and safety guidance regarding the reopening of schools. As new information becomes available, the Network Office will support school administration in revising policies and procedures as well as communicating updates with families and staff.

2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

Continuity of services for all students returning to our buildings for the 2022-23 school year is a top priority for Freire as we prepare to begin the year with a 100% in-person instructional program. We will be able to maintain continuity of services within staffing and programming during the summer as well as the 2022-23 school year with ESSER III funding.

During the 2022-23 school year, TECH Freire will ensure continuity of services with increased teaching and student support roles. ESSER III funds enable us to fund the salary and benefits of new and existing positions that support student growth both academically and socially. Funded positions include building substitutes, an elective/enrichment teacher that will teach an entrepreneurship course, school counselors, Attendance and Community Outreach Coordinators, and a school nurse. In conjunction with ESSER III funding, we maintain the ability to transition our robust Emotional Supports program to a completely virtual format if needed to support continuity of services within the virtual-learning program as well as to expand the flexibility of our in-person program in the 2022-23 school year.

<b>a. Universal and correct wearing of <a href="#">masks</a>;</b>	Freire Charter School's policy on face masks currently indicates masks are optional for all individuals while in the building. We will continually monitor CDC as well as state and local guidelines for updates to inform any possible changes.
<b>b. Modifying facilities to allow for <a href="#">physical distancing</a> (e.g., use of cohorts/podding);</b>	Current guidance for schools has deprioritized distancing so we are returning to standard spacing in classrooms and hallways. We will continually monitor CDC as well as state and local guidelines for any changes.
<b>c. <a href="#">Handwashing and respiratory etiquette</a>;</b>	<p>Hand sanitizer is readily available throughout the building especially in high-touch areas.</p> <p>Staff will continue to reinforce handwashing and respiratory etiquette by guiding students on all health and safety protocols and following CDC guidelines, with a significant emphasis on handwashing and other hygiene/etiquette procedures.</p>
<b>d. <a href="#">Cleaning</a> and maintaining healthy facilities, including improving <a href="#">ventilation</a>;</b>	<p>Freire Charter School has developed intensified cleaning and sanitization schedules and procedures for each campus according to current CDC and OSHA guidelines.</p> <p>MERV-13 filters and air ionizers in the central HVAC to support greater air filtration.</p> <p>We will continually monitor CDC as well as state and local guidelines for updates to modify our cleaning, ventilation, and sanitization procedures and protocols.</p>

<p>e. <b><u>Contact tracing</u></b> in combination with <b><u>isolation</u></b> and <b><u>quarantine</u></b>, in collaboration with the State and local health departments;</p>	<p>Per updated CDC guidance for schools, we are discontinuing contact tracing and quarantine for exposure. Students or staff with a COVID exposure in the home must wear a mask for 10 days and are recommended to test on day 5. We will continually monitor CDC as well as local guidelines and modify protocols as needed.</p>
<p>f. <b><u>Diagnostic</u></b> and screening testing;</p>	<p>In the 2021-22 school year, TECH Freire partnered with Children’s Hospital of Philadelphia’s Project: ACE-IT to provide COVID-19 assurance testing via BinaxNOW Antigen tests.</p> <p>In 2022 ownership of Project: ACE-IT transferred to the Philadelphia Department of Public Health. Freire Schools has signed on to continue with Project: ACE-IT as its primary source of Rapid Antigen testing.</p> <p>Testing will focus on students/staff with symptoms or those who have had an exposure (on day 5). We will not regularly do surveillance testing.</p>
<p>g. Efforts to provide <b><u>vaccinations to school communities</u></b>;</p>	<p>In the 2021-22 school year, TECH Freire Charter School provided three “Dragon Vax” clinics in partnership with Children’s Hospital of Philadelphia and CareForce MD. These clinics provided first and second doses and boosters of the Pfizer vaccine for students and staff.</p> <p>In 2022-23 The Freire Network will continue to promote COVID vaccinations and boosters for students in accordance with CDC and state and local guidelines.</p>
<p>h. <b>Appropriate accommodations for students with disabilities with respect to health and safety policies; and</b></p>	<p>Additional protective equipment will be provided, as appropriate, for settings that require close human contact, such as staff providing support for students with disabilities and counseling services.</p>

	<p>Emotional Supports services will also continue to be available virtually to students in 2022-23 when needed. We will continually monitor CDC as well as state and local guidelines for updates to modify our accommodations to students with disabilities.</p>
<p><b>i. Coordination with state and local health officials.</b></p>	<p>TECH Freire Charter School has submitted its Health and Safety Plan to the appropriate state and local health officials. As new information on health and safety guidelines develops, we will adapt our policies and procedures to the new guidance and submit our plans to the relevant health officials. We will keep communicating with state and local health officials to ensure we are aligned to their directives.</p>
